This request for £500 is for our support for increase of services of the Community Transport Scheme , to help give increased services to Blidworth . To assist in this scheme there is a need for the 35 volunteer drivers who , to comply with Health & Safety requirements , will need Black/Yellow reversible jackets with embroidered Logos at a cost of £2,508 . Cllr Mrs Y Woodhead agreed it is a worthwhile cause & Proposed a Grant of

£1,000 , being £500 Re new jackets & £500 Re Blidworth Plus Bus Project – Cllr A Fell Seconded above , & it was Unanimously Agreed .
