Councillors discussed the many accidents that had occurred on the junction with Blidworth Lane/Warsop Lane. The Clerk to look into this to ensure a record is kept. If necessary, a FOI request could be sought to determine the number of accidents on these roads. **Clerk**

It was **resolved** to approve the Analysis and payments and receipts for the months of November, December and January and to authorise the schedule of payments for February (105.1-105.5) including 1 additional payment of £120.14 for the Mower vehicle insurance – making a total of £16559.35.

It was **resolved** to accept the Financial Risk Assessment.

23/106 To agree – Precept for the Financial year 2023/24 including:

- 106.1 To note Forest Folk Allotment annual payment increase in line with inflation The increase of £75 was noted making the annual payment a total of £630.00. A new agreement had been sent to the Forest Folk Allotment Society for signing.
- 106.2 To note Salary increases for 2023/24 in line with NJC Payscales These were noted, and were agreed in line with the Green book agreement to which both employees are employed. Any future pay increases to be implemented as per instruction from NALC.
- 106.3 To agree Library provision for next 3 years and agreement with Inspire (Emailed out to Councillors 31st January)

This was discussed in length and the cost involved via benefit to residents.

It was **resolved** to enter into both agreements for the library space and Parish Council meetings at a cost of £1650 per annum, and for the additional library opening and staffing at a cost of £3430 per annum for a 3 year term. The Parish Council to request a right to review this annually with an option to withdraw.

106.4 To consider future projects/expenses for the year 2023/24 and agree the proposed budget

Cllrs Catling and O'Hare talked through the figures following discusion by the Working Party at their meeting last week. Projects were discussed and agreed alongside the amount in the

reserves.

It was **resolved** to agree the proposed budget.

106.5 To agree – The precept request from Newark and Sherwood District Council for the year 2023/24

In accordance with Council Tax (Demand Notices) (England) Regulations 2011 Blidworth Parish Council **resolved** for the precept requested from NSDC for 2023/24 to be ££90323.00

107.1 To update – Jubilee mural board

Cllr Catling updated members, this was not moving forward with Newark and Sherwood District Council. Cllr Catling had spoken to Blidworth Oaks. It was suggested that Blidworth Art club could reinstate this. To be looked at further and brought to the next meeting.

- 107.2 To update Moving forward with a Neighbourhood Plan.
- The Chair updated members. Despite phone calls and researching it had been had not been possible to move this forward due to time scales. The closing date for applications was the 31st Jan and any funds awarded needed to be spend by 31st March. This was to be picked up again in June, (by potentially new Parish Councillors Elections dependent).
- 107.3 To update Blidworth Walking trail and information board Cllr O'Hare updated members about the meeting she had had with Miner2Major where an 'App' had been discussed to enhance the trail. Cllr O'Hare to come back with costs etc. and a plan of the trail.

- 107.4 To discuss Allocation of 106 money and meeting with residents A meeting has been arranged with NSDC for the 23rd February to move this forward.
- 107.5 To approve service of Toro Mower It was **resolved** to have the Toro mower serviced by PS Marsdens at an estimated cost of £1200.

The Clerk updated members that she had enquired about having a towbar fitted to the mower, in order to pull a small trailer. They had provided an estimate however, confirmed that it was likely that a tow bar would be unsuitable for the mower.

It was **resolved** to not move forward with this.

- 107.6 To discuss Extreme skating event on Sherwood Park 20th May NSDC had confirmed that they had agreed some funding for Blidworth to have an 'Extreme Skating Event' on Sherwood Park. A date had been agreed of the 20th May. Further details to be circulated when confirmed.
- 107.7 To discuss Street naming and suggestions from residents This item was deferred.
- 107.8 To discuss Change in agreement for use of 106 Money from Belle Vue Lane The Clerk updated members that NSDC had agreed in principal that the agreement could be changed for the money to be spent for use at Sherwood Park. They needed confirmation of various items and the planned expenditure. This to be looked at if and when the grant applied for is confirmed.
- 107.9 To discuss Telephone line and broadband for Parish Council Although discussed and agreed at the January meeting. New information had come to light which would ensure continunity of the Parish Council phone number and email address. BT had offered a better deal which would mean the Parish Council could continue to keep the Broadband and phone line, keeping both the Parish Council email address and phone number. This would be a cost of £28.95 per month (for a 2 year contract).

It was resolved to accept this offer.

107.10 To agree – pop up nature sessions from YMCA

The Clerk updated members regarding the YMCA who are wanting to run several sessions in the community at the parks to promote nature making bird boxes, flower bombs etc. The Clerk had been sent a copy of their Public Liability Insurance.

It was **resolved** to allow access to the Parish Councils green spaces. Cllr Rea to liaise with the YMCA to move this forward, and promote as necessary.

107.11 To discuss – Grant award from NSDC for CCTV at Sherwood Park The Clerk confimed that the grant of £10,000 towards the CCTV at Sherwood Park had been received. This was to be returned to NSDC if it isn't spent before October 2023. The Clerk had asked Andy Hardy to chase the CCTV team for prices etc. which had not been progressing.

It was agreed for this to be looked at by the Parks WP to see what the requirements of the CCTV are.
